Application to Register Boats

SPECIAL NOTICE - ZEBRA MUSSELS

The Zebra Mussel now poses a multi-million dollar threat to Lake George. Zebra Mussels reproduce rapidly forming dense colonies which can foul boats and boat engines, beaches, water intakes – virtually any hard surface and they can effect the overall ecology of a lake.

Adults can be transported over land attached to boats, trailers, anchors, exhaust pipes, etc.

Microscopic larvae can be carried in the water of engine cooling systems, bilges, live wells and bait buckets, etc.

Please, before launching your boat in Lake George and when leaving

- INSPECT** Thoroughly inspect your boat's hull, drive unit, trim plates, trolling plates, prop guards, transducers, anchor and anchor rope, and trailer. Scrape off and trash any suspected mussels, however small. Remove all water weeds hanging from boat or trailer. **Inspection and removal of marine growth is required and appreciated to protect the lake's environment.**
- DRAIN** Drain all bilge water, live wells, bait buckets and any other water from your boat and equipment. Trash leftover bait at the boat launch site; leftover live aquatic bait should not be taken from infested waters to un-infested waters.
- WASH** Thoroughly flush the hull, drive unit, live wells (and live well pumping system), bilge, trailer, bait buckets, engine cooling water system, and other boat parts that got wet while in infested waters, using a hard spray from a garden hose. If your boat was in infested waters for long period of time, or if you found any attached adult mussels, use **HOT** water instead of cold, or tow the boat through a do-it-yourself carwash and use the high pressure hot water to "de-mussel" your boat. **DO NOT** use chlorine bleach or other environmentally unsound washing solutions.
- DRY** Dry after boating. Boats and trailers should be allowed to dry thoroughly in the sun for 2 to 4 days before being launched into un-infested waters.

ZEBRA MUSSEL FACTS

- An exotic organism called the Zebra Mussel now threatens Lake George.
- Zebra Mussels propagate rapidly forming extremely dense colonies and attach to any hard surface including other mussels.
- The Zebra Mussel secretes a glue like substance to attach to hard underwater surfaces including boats and water intakes. Engine problems such as overheating and propeller damage often result from Zebra Mussel encrustation.
- Zebra Mussels' appearances vary, although most have jagged lateral black or brown stripes. They can grow up to 2 inches but most are under an inch long. They are the only freshwater mussel that can attach itself to solid objects.

- The Zebra Mussel's most serious threat is its impact on the food chain. By consuming the base organisms of the food chain, phytoplankton, and zooplankton, they disrupt the aquatic environment.
- Adult Zebra Mussels were first found in Lake George in late 1999. A concerted hand harvesting effort has reduced the colony and continues toward the goal of eradication.

THE BOAT REGISTRATION FEES ARE DEPOSITED TO THE LAKE GEORGE PARK TRUST FUND AND CAN ONLY BE USED BY THE COMMISSION TO PROTECT THE LAKE AND ITS USERS. THE COMMISSION IS AN INDEPENDENT AGENCY OF NINE VOLUNTEER CITIZENS, RESIDING IN THE THREE COUNTIES BORDERING THE LAKE, AND THE ENVIRONMENTAL CONSERVATION COMMISSIONER EX-OFFICIO.

STATE LAW REQUIRES THAT ALL VESSELS 18 FEET OR LONGER, OR ANY VESSEL MECHANICALLY PROPELLED BY A MOTOR 10 H.P. OR GREATER, MUST REGISTER WITH THE LAKE GEORGE PARK COMMISSION AND DISPLAY A REGISTRATION DECAL.

CALCULATING YOUR ANNUAL BOAT FEE: First determine whether the boat to be registered is "equipped for overnight accommodations". Boats equipped for overnight have a bed or bunk and sanitary facilities such as a toilet, shower, sink, kitchen, whether or not a marine toilet has been removed from the vessel. Boats may be equipped for overnight whether or not used for overnight stays.

Next, determine the boat length. Boat length is the distance overall from the foremost part of the bow to the aftermost part of the stern excluding bow pulpits, swim decks, engines, props, brackets, etc. Many boats have a capacity plate which provides the overall length, or check your state registration documentation.

Fee schedules require rounding UPWARD to the next highest full foot for boats longer than 25 feet. Read across to find the category (equipped or not equipped). Read down to find the fee for the boat length. Sign and Date Registration Form.
